

Photography at West Milford Farm

IT IS YOUR RESPONSIBILITY TO PRINT THE GUEST RELEASE AND BRING WITH YOU WHEN YOU VISIT AND HAVE ALL GUESTS YOU BRING ON THE PROPERTY SIGN THE REALEASE OF LIABILITY

- **Becoming an approved photographer-** To photograph at West Milford Farm, you must be an approved photographer on our list. In order to be approved, you will need to submit the form on the back of this page to us so we have contact information etc. You can email it back or bring it with you when you visit.
- **We reserve the right to cancel your session-** We welcome anyone to come to the farm to take pictures anytime we are not booked for an event. You may book as far in advance as you like however- We are primarily an event venue and should we book an event on a date you have scheduled for photography, you will have to re-schedule on another available date. For that reason, we highly recommend weekdays for photography. Weekend Dates (Sat. and Sun.) are reserved for exclusive all day rentals ONLY (\$400) but are still subject to rescheduling should we book an event on the day you reserve.
- **Fees-**
 - **Week day Share the farm-** The cost is \$50 for a 1 hour session. You must select the hour(s) you would like when you book and pay the day of the photography. If it is raining or inclement weather the day you have booked, you may re-schedule at no charge. We allow 2 photographers here at one time and you shoot around each other. Please do not monopolize one part of the farm for over 1/2hour during your session.
 - **Week day Exclusive by the hour-** If you need to be at the farm alone, the fee is \$100 for an hour. The photographer who books first will have first choice of location the day of photography.
 - **Weekend All Day Exclusive-** Photographers who would like to book the farm for the day or more than 4 hours can pay \$400. This is also the fee for styled shoots, photography classes/workshops etc. If you book for the entire day, we will not allow another photographer to be here on the date you book. Again, you may book as far in advance as you like however- We are primarily an event venue and should we book an event on a date you have scheduled for photography, you will have to re-schedule on another available date.
 - **Weekend by the hour-** If you book less than 30 days out and we have a weekend date open, we will allow hourly rates to apply on Saturdays and Sundays.
- **How to Book-** Photography can only be booked through Chad via **email only** with the date, specific time you'd like to come, and the hour/hours you would like to book. chad@westmilfordfarm.com We receive a tremendous amount of requests for photography from social media, text, phone, and email and for that reason we are asking that **all requests come through email** so it can be easier to keep up with.
- **Using our props-** You may move things around (within reason) but please put them back where you found them. THIS INCLUDES PLANTS IN THE GREENHOUSE-

- **What to do when you arrive and how to pay-** Turn in your application and liability releases for all your clients. You need to print out copies of each and leave these in the mail box on the outside of the barn by the handicapped entrance to the main event hall. You pay also leave check or cash in an envelope with your name on it. Or pay with Venmo.

ACKNOWLEDGMENT OF RISK AND WAIVER OF LIABILITY

In exchange for West Milford Farm, LLC's allowing you ("Guest") to participate in photography at West Milford Farm Guest agrees as follows:

Guest acknowledges the following with respect to coronavirus / COVID-19 (the "Virus"):

- (1) the virus is extremely contagious and thought to spread between people who are in close contact with one another, through droplets produced when an infected person coughs or sneezes, and/or through touching inanimate objects such as door knobs;
- (2) various government and quasi-government entities have recommended that the public avoid groups of more than 10 people; more restrictive recommendations and/or requirements have been imposed in other parts of the United States and abroad and may be imposed in the future;
- (3) the Virus has no vaccine;
- (4) the Virus may cause hospitalization, serious temporary and permanent physical injury, and death; and
- (5) Guest and/or any other guest may be infected with the Virus but may not show any symptoms.

Guest understands that attending any activities at the West Milford Farm may expose Guest and anyone in contact with Guest to the Virus and the potentially harmful effects of the Virus. This release does not include a release of any gross negligence or willful misconduct on behalf of any of the Released Parties.
